1. Introduction

The Swiss Wind R&D Network was founded with the founding meeting on 06.02.2020. This document introduces our plans for 2022 and complements the Annual Report 2021 (*Network_AnnualReport_2021.pdf*). In Section 2, the planned work is introduced. In Section 3, the budget is presented.



2. Planned work for 2022

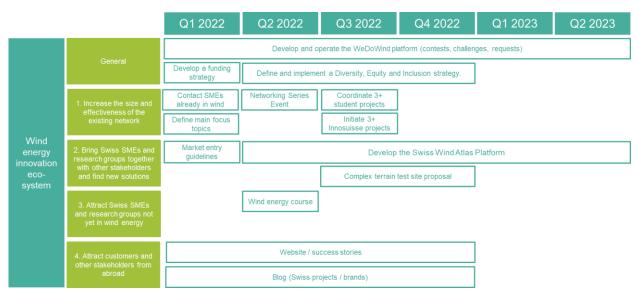


Figure 1. Action Plan 2022.

An Action Plan was developed at the end of 2021 based on the strategy and goals presented in the Annual Report 2021 (*Network_Annual_Report_2021.pdf*), and is shown in Figure 1. The individual tasks have been assigned to the seven Working Groups (WG) in Figure 2. As part of WG1: Administration and coordination, we plan to:

- Operate and improve the WeDoWind platform.
- Define main focus topics.
- Develop market entry guidelines.
- Improve website / include success stories.
- Write regular blog (Swiss projects / brands).

As part of WG2: Events, we plan to:

• Run the second Innosuisse Event Series event in June.

As part of WG3: Projects, we plan to:

- Initiate 3+ Innosuisse/BFE projects.
- Initiate new projects related to the improvement of the Swiss Wind Atlas.
- Communicate success stories of EU projects.

As part of WG4: Teaching, we plan to:

- Set up student project coordination and coordinate at least three projects.
- Run a wind energy course.

As part of WG5: Fund-raising, we plan to:

- Submit WeDoWind funding proposals.
- Submit a "Complex terrain test site" proposal.
- Develop a funding strategy, including sponsoring and donations.

As part of WG6: Accounts, we plan to:

• Run the accounts professionally according to the agreed procedure.

As part of WG7: Diversity, Equity and Inclusion, we plan to:

• Define and implement a Diversity, Equity and Inclusion strategy.

3. Budget plan 2022

The budget plan for 2022 is shown in Table 1. As well as the revenue and expenses for the Innosuisse Event Series project, we have assumed a revenue of CHF 50'000 for the WeDoWind project. This will come from the different proposals currently being written by OST, FHNW and ETHZ related to the project. We will use this money on OST, FHNW and ETHZ staff costs (CHF 40'000) as well as on fees to companies such as Stacker Group, who support us with the WeDoWind platform. Finally, we intend to gain CHF 50'000 in sponsorship. A strategy for this is currently being developed.
